4. To make the rural public to be aware of Government Schemes. The Trust will print publish, pamphlets, Booklets etc and provide periodicals, newspapers and books to spread the social, medical and information regarding Govt. schemes.
5. To introduce appropriate rural technologies to develop the economic conditions of the people.
6. To cater the religious urge of all Religions, Organize / arrange pilgrimage / lectures, discourses and facilities for cremation / burial.
7. To undertake all kinds of unclaimed dead bodies & arrange for cremation / burial.
8. To run orphanages for the rural / semi urban poor children & neglected ones.
9. To mould the children to be true and dutiful Citizens.
10. To urge the youth to lead a self-disciplined life which prohibits all kinds of harmful food and drinks and avoid perverted arts, music and literature.
11. To create Awareness on the importance of donation of blood, eye and useful parts of human body. To organize and establish youth groups, women volunteers for this purpose.
12. To establish and administer hospitals and dispensaries & clinical Laboratories, mobile medical van facilities wherever necessary for the welfare of Rural / Semi Urban public.

13. To run employment oriented courses such as B.Pharm, D.Pharm, B.Sc., Nursing Course, Medical based vocational training such as DMLT and Diploma in Nursing etc.
14. To find ways and means to impart industrial training to the physically orthopaedically handicapped and mentally retarded.
15. To help and promote rural / semi urban community in creating opportunities for women employment by arranging and developing cottage industries, dairies, agricultural farms, gotaries, piggeries, cattle feed and poultry feeds / coir works and milk products industry and alike.
16. To educate the rural mass on environmental / industrial pollutions and to create environmental awareness at gross root level.
17. To survey child labour, street roaming children, and adolescents and do the needful for their basic needs, education and rehabilitation.
18. To co-operate with the government in all its developmental schemes, plans and other activities which work towards welfare of poor, children and women, destitute and neglected ones.
19. To arrange and establish Eye Foundations and Free Blood donating forums.
20. To help the unemployed youth in all possible ways, such as forming small scale industries, gardening of kitchen and HERBAL plants and alike in order to make themselves self-reliant and self-supportive.
21. To generally promote or help to promote an all round welfare of all **and in particular, the socially, economically and educationally downtrodden people of India without any kind of discrimination.**
22. To adopt remote villages for the all-round benefit of rural mass.
23. To arrange village level study centers / coaching classes to the students for all types of entrance examinations.
24. To create awareness on Government schemes, Projects, Government Grant-in-Aid and loans, conducting awareness generation projects / Camps to Aids prevention and allied subjects all most in all the remote villages.

25. To undertake and assist in Socio-economic development programs and projects for improving the quality of life of the rural poor and the under privileged.
26. To initiate, administer and assist programmer for providing better Nutrition for children and expectant mothers and old age people in the most backward rural and semi-urban areas.
27. To assist rural public in the re-settlement and Rehabilitation centers in the Tribal areas.
28. To materialize the objectives of this Trust into real practice by conducting Seminars, workshops on Green Philosophy, HERBAL plantation and its usages and to protect National Resources, Vegetation and its productions.
29. To help the physically challenged persons (Blind, Dumb, Orthopedically, Handicapped / mentally retarders) by providing shelter, giving training, conducting workshops, providing financial support and necessary appliances and guide lines regarding placement of employment.
30. To help the women and children in particular the pregnant women and lactating mothers by creating awareness on balanced diet with available local resources and also to educate the mothers regarding breast feeding and the importance of mother's milk as well the importance of Nutritious food to them and their children.
31. To generally promote or help to promote the interest and all round welfare of all the socially, economically and educationally downtrodden people of the Nation without any kind of discrimination.

XI. BENEFICIARIES OF THIS TRUST

1. Economically weaker sections, downtrodden, physically challenged persons and mentally retarded.
2. Neglected Communities, wards of prisoners / wards of HIV affected ones, children of sexual laborers and street roaming children, vendors / Hawkers.

3. Senior Citizens, Women in distress, widows, destitute, children (orphans, physically challenged, mentally retarded)
4. Rural based youth and uneducated rural / Semi urban mass.
5. Agricultural Labourers, Agriculturalist, Cultivators and allied industrial labourers.

All the beneficiaries of the Trust shall be treated equally without discrimination of **caste, color, creed, religion or gender**.

XII. AREA OF OPERATION OF THIS TRUST:

The activities of the Trust shall be confined to the limit of Tamil Nadu State as well with in the TERRITORY OF INDIA.

XIII. WAYS & MEANS TO IMPLEMENT THE OBJECTS

- a. The Board of Trustees may assemble from time to time and decide ways and means to achieve the goal of the Trust. They may apply the funds of the Trust in carrying out all or any of the above said aims and objectives of the Trust as they may deem fit.

- b. For the achievement of the objects enumerated above the following rights may be helpful in realization of the object of the said Trust.

C. The Rights may identify as detailed below:

2. Raising funds through Donations, subscriptions, lucky draw and benefit performance.
3. Acquiring, letting, Leasing and purchase or sale of property.
4. Raising Loan.

Though the Trust has been formed with five persons, to maintain quorum, the Chairperson (C) First Managing Trustee may nominate more board of Trustees / advisory committee not exceeding 4 nominated members. At any cost the Board of the Trustees should not exceed nine, inclusive of the principle five Trustees. The Board of Trustees should be in odd number.

XIV.B: GENERAL

1. The Board of Trustees may Co-opt eminent persons, as patron / Advisor and Experts, Educationists, Social Workers, persons deemed fit to fulfill the objectives of the Trust as Co-Trustees.
2. The Trustees may Co-opt persons not exceeding 3 at a time.
3. The Trustees chosen for the causal vacancies caused on resignation, death or terminations shall hold the office only for the unexpired part of the term of the Trustee causing the vacancy.

4. The Chair Person is empowered to sign all documents, statements and other necessary records and receive and issue receipts for money coming in or going out or other transactions.
5. For the smooth functioning of the Trust activities the Chairman (Cum) Managing Trustee may nominate or appoint a person on salary or honorary basis as Member Secretary for a specific period and authorize in writing the Member Secretary to sign the documents related to the Trust on all the matters / transactions referred to herein after.
6. The Bank Accounts in the name of the Trust shall be operated jointly by the Chairperson along with the Member Secretary or any one of the Board of Trustees.

XV. POWERS AND DUTIES OF THE BOARD OF TRUSTEES:

CHAIRPERSON:

- a) The CHAIRPERSON (C) FIRST MANAGING TRUSTEE will be the advisor and guide for the **"SREE SHANMUGAM EDUCATION TRUST"**
- b) The CHAIRPERSON (C) FIRST MANAGING TRUSTEE shall have all and every power for the purpose of Managing, Conducting and administering the affairs of the establishment covering the objects of the said Trust.
- c) However for the smooth and effective functioning of the activities, she can Sub-delegate her powers to the person whom he feels fit.
- d) The CHAIRPERSON in opinion with her Co-Trustees by a resolution passed may open one or more bank accounts in the name of the said Trust with any nationalized Banks or post Offices as the Trustees deem fit.

- e) The CHAIRPERSON may enter into Contract with any person (or) body of persons (or) Institutions and Voluntary organizations for any purpose covering and to achieve the objects of the said Trust.
- f) The CHAIRPERSON shall once in every year place before the Board a report of the working of the said Trust. Further he shall furnish information to the Board as they may be required and as may arise from the reports.
- g) The CHAIRPERSON shall at every annual meeting of the Board, place before the Board, the auditor's statement relating to the accounts of the various activities comprised in the Trust.
- h) The CHAIRPERSON shall be the Executive Officer of the Board and as such shall be responsible for the custody of records and properties of the Trust, shall have power and authority for and on behalf of the Board.
- i) The CHAIRPERSON hereby appoints Mr. K. VIJAYAKUMAR as a Nominated Member Secretary to assist the Board as well the Chairperson (C) Managing Trustee.

XVI. POWER AND DUTIES OF MEMBER SECRETARY:

- a) Subject to the control of the Board of Trustees, the member secretary can act as co-executive officer, of the said trust. He / She shall be sole charge of the entire functions of the Board of Trustees and shall be entitled to act on behalf of and in the name of the trust without prejudice to the foregoing general authority granted to the Member Secretary by the Managing Trustee / Trustees.
- b) The Member Secretary shall maintain or cause to be maintaining all accounts of income from Trust properties and incur expenditure for the administration of the Trust activities.

- c) He / She shall operate the bank accounts under authorization of the Board of Trustees from time to time.
- d) The Member Secretary is responsible to arrange periodical meetings to carry over the business of the trust.
- e) The Member Secretary has to maintain a minute book and minutes of the proceeding of every meeting shall be entered and signed by the Managing Trustee and Trustees.
- f) He / She shall execute, implement decisions of the Board and keep accounts of the Trust.

XVII. SUB-DELEGATION OF POWERS TO MEMBER SECRETARY:

Under Sub-Delegation of Powers she / he may carry over the following:

- a) Invest monies of the trust as decided upon in the Trustees Meeting in accordance with Indian Trust Act, 1882 and Income Tax Act, 1961 and rules.
- b) To demand claims and receive any money due to the Trust from any person(s) and to issue valid receipt there for.
- c) To institute or defend and conduct all legal proceedings for and on behalf of the trust.
- d) To sell any security standing in the name of the Trust if and when deemed necessary with reference to the resolution passed in the Board Meeting.
- e) To raise any loan without security as may be required for the purpose of the fund to achieve the aims and objects of the Trust.

XVIII. POWERS AND DUTIES OF THE BOARD OF TRUSTEES:

- 1) The Trustees shall have full control over Management. All the affairs of the Trust activities and may from time to time made rules, By-laws for the proper conduct of the business based on the objectives of the Trust.
- 2) To authorize one or more persons to act as Trustees for the Trust in respect of special matters.
- 3) To set up committees, Governing Bodies or other institutions for running, administering or development of any social organization to be managed or administered by the trust, if needed.
- 4) Trustees shall have power to authorize to the Trust and to receive donations in any form.
- 5) Shall have powers to sell, purchase, exchange and deal with any stocks and other securities as directed by the Board.
- 6) Shall have powers to accept, endorse, discount, negotiate, execute and issue promissory notes, bill of Exchange, Hondas, cheques, Government and other securities and negotiable instruments.
- 7) Shall have powers to borrow from time to time such sum or sums of money at such interest for such period and sum of such terms with or without securities, movable or immovable as the Trustees may think fit with the concurrence of the Board.
- 8) To secure payment with interest by mortgage or by board of promissory notes bills, hundies and other negotiable securities.
- 9) Shall have powers to grant loans, scholarships, donations, boarding and lodging charges, books, uniforms, medicines and clothing.



- 10) Shall have power to control and manage the assets of the Trust and to execute become party to sign, acknowledge and register all deeds, documents agreement contacts and other writings to give effectual discharge on behalf of and against the Trust.
- 11) Trustees may receive loans, donations, bequests, contributions, grant-in-aid etc., from any person including individuals, firms, companies, charities or other Trusts or funds from Government, Industries like khadi village Industrial board, Govt. departments like social welfare, women & children, Harijan welfare, human resource, Health and youth ministry, Ministry of social justice & women Empowerment, and Ministry of Agriculture for the attainment of the objects of the Trust. On such terms and conditions of the Trust on negotiable terms based on the resolutions passed.
- 12) Shall have powers to appoint such staff for administering the Trust property and the Institutions maintained by the Trust on such terms as they decided from time to time and shall have powers of dismissing a person so appointed.
- 13) Shall have powers to frame rules and by-laws for the said Trust whenever necessary and to name amendments there to, when deemed necessary.
- 14) In general, shall have powers to delete all or any of the powers, authorities and directions vested with them and to carry out such transactions as they consider expedient in the interest of the Trust and to make all such arrangements and do such acts and things on behalf of the Trust as may be necessary, desirable and expedient the management of the affairs of the Trust. All the vital decisions have to be taken jointly by the Board of Trustees and Co-Trustees.

XIX. GENERAL:

- a) The trust deed may be amended by a resolution passed by three fourth majorities of Trustees present and voting at the meeting of the Trustees specially convened for the purpose after giving notice of not-less-than fifteen days.
- b) The Board of Trustees shall maintain true and correct accounts of all Trust monies and of all income and outgoing expenses.
- c) A Chartered Accountant shall be appointed to audit the accounts every year.
- d) The Trustees shall have power to appoint auditors and legal advisors or empower the Chairperson and the Managing Trustee to engage such person on part-time basis (or) on contracts.
- e) **Trustees shall not be entitled to any direct or indirect benefit out of income of the funds of the Trust.**
- f) Trustees are entitled to re-imbursement of actual expenditure if any incurred in the administration of the fund or objectives of the Trust.
- g) The business of the Board shall be dealt with at the board meeting and in emergencies by resolution in circulation. The Board meeting shall be held once in three months at the minimum.
- h) The notice period of the meetings of the Board of Trustees is seven days and the communications shall be sent to their address registered in the office of the Trust.
- i) The number of Trustees at any time shall never be more than nine inclusive of nominated / Co-opted Trustees.
- j) The financial year of the Trust for its transaction is first of April to 31st March every year. The first of which is to be closed on 31st March 2014.

- k) The income of the funds of the Trust shall be invested as per sections 11(5) and 13(d) of the Income Tax Act, 1961.
- l) All or any of the amendments to the deed of this Trust shall be made only after carrying out a resolution at the meeting of the Board of Trustees and such amendment shall not extend to alter the basic character and objectives of the Trust or repugnant to the provisions of the Income-Tax Act, 1961 and Trust Act 1882.

XX ACCOUNTS AND AUDIT:

- a) Under the sub delegation of powers, the member secretary, shall maintain by keeping proper books of Account, for the money coming in or going out such as all assets and liabilities. He / She shall prepare income and expenditure, Balance Sheet / Statements on behalf of the trust each year and place before the Auditor for auditing the accounts as well place the Audited statement of Accounts before the Board.
- b) Every year the Accounts of the Trust be audited by a Chartered Accountant or by a company of Chartered Accountants. The Chairman (C) First Managing Trustee has been empowered to appoint a chartered accountant as Trust Auditor or he may engaged the Auditors on contract basis. The Audited statement of Accounts shall be placed before the Board of Trustees at its annual meetings.

(c) BANK ACCOUNTS AND OPERATION

THE CHAIRPERSON is empowered to open Bank Accounts in the name of this Trust in any of the Nationalised Banks as Joint Account. The said Joint Account will be operated jointly by the CHAIRPERSON and the Member Secretary or any one of the Board of Trustees.



XXI. ANNUAL MEETINGS:

Annual meetings shall be held during the first week of June every year. 15 days' notice in writing shall be given to each of the Board of Trustees, specifying the place, date, time and Agenda of the meeting.

The notice be specific with information regarding resolutions to be moved, subjects to be discussed. A copy of the auditor's report and copy of the budgets to be placed before the board for the coming year shall also be sent.

XXII. TERMINATION OF THE OFFICE OF THE TRUSTEESHIP:

The Trusteeship shall cease to hold office as Trustee in the following circumstances.

1. On being adjudged as an insolvent by a court of competent jurisdiction.
2. By becoming insane or adjudged as a lunatic under the Indian LUNACY Act.
3. On being convicted by any criminal case for an offence involving moral turpitude.

XXIII. DISSOLUTION OF THE TRUST:

When and if the Trust ceases to function, the assets and interest of the Trust shall revert to some other similar objectives of this Trust.

XXIV. ASSETS:

The founder (c) Chairperson has raised an **initial corpus fund of Rs.6,000 (Rupees Six thousands0 only)** in the name of this Trust. Other than the corpus fund, no movable or immovable assets to the Trust at present.

XXV. QUORUM:

The Quorum of the meeting of the Board of Trustees shall be two third of the Trustees on role.


XXVI. NOTE: THE TRUST AND ITS AUTHOR – IRREVOCABLE**(A) DISPUTES AND ARBITRATION:**
