- ❖ that in all other necessary aspects the sanitation is satisfactory.


**SUBJECT CONDITION:**

4. No sale tobacco within the radius of 100 meters of the educational institution (Head Master/ Principal should ensure)
5. No sale of tobacco inside the premises of the institution.
6. No smoking or chewing of tobacco inside the premises of institution.
7. All the Government (state / Central) health schemes to be implemented without any deviation.

**This certificate valid for One Year from the date of issue.**

**That if any of the above conditions are not satisfied the certificate given will be withdrawn.**
